Any existing balances on Neighborhood Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

#### Minimum Interest Charge:

The minimum interest charge will be charged on any dollar amount.

For California Borrowers, the Visa Platinum and Signature Rewards are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.
